Preliminary plat. See Nampa City Planning & Zoning. Fire Inspection Fee is \$160 + 1.00 per lot. The city of Nampa collects fee.		
Final Plat City. See Nampa City Planning & Zoning. Fire Inspection Fee is \$50 Flat. The city of Nampa collects fee.
