## Special Burn & Bonfires Permit Application

This is not a regular "burn permit" which is good for 1 year. If you are looking for the Burn Permit application, please visit the NFPD website for more information. The "special burn permit" is good for a limited and specific burn. This permit shall also apply to bonfires not located in an enclosed 2' x 3' fire pit.

### **RESPONSIBILITIES, REQUIREMENTS & CONDITIONS - (Check that you understand & will comply)**

Provide a site plan with this application showing location of fire, details on size of the bonfire and distance to structures, fences and other combustibles.
Provide an activity description with this application that includes: the size of the proposed bonfire, type of fuel, description of the ground under and surrounding the bonfire, description of the ring or enclosure, types of fire prevention measures and duration.
Applicant/Owner (competent person) must be in attendance until fire is completely put out.
No burning shall be done closer within 30 ft to any structure.
Water source such as a garden hose will be at burn as well as additional tools (e.g., shovel, rake, etc.)
Do not start fires ½ hr before sunrise & have fires extinguished and completely out ½ hr after sunset (at latest).
<b>Burning Materials:</b> Tree and shrub limbs up to 2" diameter, gardens, field, clean & dry lumber, ditch banks, weeds less than 18" tall may be burned. Weeds over 18" tall must be removed, cut down or trimmed.
<b>Materials that may NOT be burned</b> include but, are not limited to garbage, dead animals, plastics, petroleum products, paints or thinners, pathogenic waste, lumber, or timber products (which may have been treated), tree limbs over 2" diameter, rubbish, paper products, tires or rubber products, composition roofing, tar/tar paper, hazardous waste, insulated wire, junked motor vehicles (or any material resulting from a salvage operation), tree stumps, leaves and grass clippings.
The <i>fire code official</i> may require an inspection before approval.
If there is smoke or nuisance complaint, The Fire Department will respond.

Violations of this policy or of Idaho statutes may result in citation
<b>Weather &amp; Air Quality Requirements</b> – All permits are subject to weather, air quality and fire danger.

AQI must be below 60. Applicant must check air quality day of burn by calling DEQ.
No permits will be issued if the winds are (or are forecast to be) greater than 10 mph.
