Construction Permits - Fire Protection Systems

As of January 1st 2026:

** If construction is started without a valid permit, the fee will be doubled for each system installed**

NEW - Fire Alarm System, NFPA 72 (2019)	
1-10 devices	\$125.00
11-20 devices	\$150.00
21-200 devices	\$200.00
201 (+) devices	\$300.00
Devices include: FACP, FAAP, heat/smoke detectors, horn/strobes, beam detectors, etc.	
Modified- Fire Alarm System, NFPA 72	
10 (+) devices and/or FACP replacement	\$100.00
New or Modified -*Additional floor charge: \$25.00 for each floor above or below the first floor	

This fee covers reviewing plans ONLY for the permit. The fire alarm acceptance testing must be scheduled with an inspection and appropriate fee paid.

This fee covers reviewing plans ONLY for the permit. The flow/flush, hydro testing, rough-in, and final acceptance test must be scheduled with an inspection and appropriate fee paid.

Fire Standpipe	\$150.00 per (4) outlets
This fee covers reviewing	plans ONLY for the permit.
Fire Pumps	\$150.00 per pump

A construction permit is required for installation of or modification to fire pumps and related fuel tanks, jockey pumps, controllers, and generators.

Commercial Hood Suppression System	\$100.00 per system
------------------------------------	---------------------

This fee covers reviewing plans ONLY for the permit. The Commercial Hood acceptance testing must be scheduled with an inspection and appropriate fee paid.

This fee covers reviewing plans ONLY for the permit. The Paint/Spray/Mixing Booth acceptance testing must be scheduled with an inspection and appropriate fee paid.

This fee covers reviewing plans ONLY for the permit. The Alternative Suppression acceptance testing must be scheduled with an inspection and appropriate fee paid.

Operational Permits

Burn Permit	\$25.00 per address

An operational permit is required for the kindling or maintaining of an open fire or a fire on any public street, alley, road, or other public or private ground.

Fireworks permit tier I (Consumer grade, private residential property)	\$50.00
Fireworks permit tier II (Consumer grade, any place with public access)	\$100.00
Fireworks permit tier III (Display/Special effects grade, professional)	\$150.00

An operational permit is required for use of fireworks displays. Must provide a bond or certificate of insurance to cover any potential damages. Teir II and III permits only submitted to a professional certified to discharge. NCFPD may waive this fee for civic or nonprofit organizations.

Amusement buildings (i.e. Haunted House, etc.)	\$50.00 per address
--	---------------------

NCFPD may waive this fee for civic or nonprofit organizations. An onsite <u>inspection is required</u> prior to the opening of a haunted house and for the permit to be valid.

Carnival and Fairs	\$250.00
